Dear Members of ACACS:

I am running to keep my School Committee seat because I believe that I have a unique and relevant skill set to offer to our District. As a former Assistant Attorney General and current municipal attorney, I have over two decades of government legal experience and expertise that can help our District avoid costly legal blunders. As the mother of two girls, I have skin in the game.

Our schools are our community's most precious and important asset. Our District is recognized for its academic rigor and excellence, and we all benefit from that recognition. There are major issues, however, that we need to meet head on. One is what some perceive as the conflict between student achievement and wellness. I think we can all agree that "wellness" is an important goal for our kids. I do not think, however, that "wellness" must mean the absence of any stress. Stress is a part of life that people experience from infancy until death. When children are toddlers, we don't try to remove all stressors and frustrations—if we did, or our children would not learn. Learning to walk is frustrating! Learning to express oneself in language and failing is stressful! Parents and teachers respond by encouraging and celebrating successes, and our toddlers learn to cope with the stress of learning new skills. This is a lifelong process and certainly K-12 should be no exception. That said, however, I do support many of the wellness initiatives, such as later school start times for junior high and high school. The developing science around sleep and adolescent brain development is pretty clear at this point, so in my opinion, arranging later start times to the extent possible is a common sense wellness initiative. I have seen its benefits first hand in my own home.

I believe that we need to look at each wellness initiative on its own merits, and to the extent that an initiative may interfere with excellent or achievement, we need to have that discussion. In these discussions, I welcome the perspectives of all communities and have especially appreciated the input from Eileen Zhang and Angie Tso. I believe that our District's cultural diversity is one of our greatest assets, and that all voices need to be at the table. That is why I think it is crucial that Eileen remain on the School Committee.

Another tough issues facing our district is the impact of elementary "school choice." I believe that we need to talk honestly about whether the advantages of this unique aspect of our District justify its continuation--and if so, how we can recognize and respond to the issues it creates. A third pressing issue is the sharp increase in families coping with serious economic disadvantages, and the impacts that can have on our schools and on students' ability to learn and thrive. I think that there needs to be

more recognition that our schools and teachers cannot address all of our children's problems. We need to make connections with other community leaders and organizations to assist with some of these issues.

I am a passionate advocate of public education, and over the last year I have put my energy to work bringing your voice to the table. I have assessed the District's past and current legal counsel and worked with the Chair, Co-Chairs, and Superintendent to ensure that, going forward, our legal counsel will be qualified, reasonably priced, and philosophically aligned with our District's values. I have worked to become deeply informed about special education issues in our District, and will continue to evaluate problems and build consensus to make needed improvements so we ensure that decisions are driven only by student need. I am also a passionate advocate of high-quality early childhood education, and will work toward universal access to all day kindergarten for all families who want it. I serve as the School Committee's legislative liaison, meeting regularly with our state delegation to keep informed of developments on Beacon Hill that will impact our District. I have relationships with key players and will continue to advocate for fair state financing for underfunded mandates, such as programs and services for English language learners and students needing special education.

I believe that I bring a unique skill set that is valuable to our District. I have built a broad coalition of diverse supporters, and I am always ready to listen – I'm truly interested in your experiences and perspective. I would be honored to have your vote on Tuesday March 26. With your support, I will continue to bring your voice to the table.
